# Child & Adolescent Services



## Services

**Assessment:** An initial visit to define behavioral health needs

**Case Management:** Provides linkage to mental health resources, family supports, and community-based services

**Outpatient Services:** Short-term individual and family therapy

**Prevention:** Efforts to promote mental health and reduce substance use in the community

**Psychiatry:** Psychological testing & medication management - must be coupled with another service

**Short-Term Crisis Counseling:** Stabilization of an acute mental health crisis episode

**Substance Use Services:** Treating mild misuse

## Eligibility

These services are available to children and adolescents ages 6-18 (up to 22 if still in secondary school) who are experiencing developmental, emotional, or behavioral issues.

## Assessment Process

Our licensed or license-eligible clinicians will assess your child to determine his/her/their needs. This meeting usually involves gathering treatment and family history, and identifying target areas for treatment and support needs.

Once complete, we will make suggestions and recommendations for treatment such as outpatient counseling, case management, and other support services.

Over the course of treatment, program providers frequently collaborate to ensure the child's needs are met. The child, family, and treatment providers work as a team to maximize services and build on family strengths.

## Fees for Services

Fees are charged on a fee-for-service basis. We accept most insurance plans and HMOs, including Medicaid. Individuals without insurance coverage are charged according to ability to pay, based on income and dependents.

## Staff

All services are provided by clinically trained, professional staff. Our services are licensed by the Virginia Department of Behavioral Health and Developmental Services.

Individuals and their families are encouraged to participate in service planning and decisions about their care.

All services are confidential.
